**Bella Kaldera:**

Bella Kaldera came in to update Board on the Recycling Center. The Recycling Center had 30 customers and took in \$414.00 dollars this past Saturday. A customer of the Recycling Center, Jeff Marinelli, reported that there is a cellar hole at the intersection of Cross Road and Mt. Jefferson Road that is being used as a dumping ground. Randy Mizereck stated that he would look into it. B. Kaldera stated that the signs for the Recycling Center are in process at Wide Angle. As soon as the signs are done, Wide Angle will call B. Kaldera.

B. Kaldera also informed the Board that Green Cycle raised prices to 55 cents a pound but feels that they can absorb the cost. B. Kaldera feels that Green Cycle is cherry picking the bins. The company comes in when it pleases them and never lets B. Kaldera know when they are coming. B. Kaldera stated that she would like to get a platform scale so that she could be more accurate in the weighing of the tv's. Randy Mizereck suggested looking into a used scale as the one presently being looked at new is \$355.00. B. Kaldera will look into a used scale and let the Board know what she finds out.

**Maureen Girard:**

Maureen Girard came in to meet the Board of Health. M. Girard said that she enjoyed her first job with the Town. Randy Mizereck thanked her for helping out. M. Girard said that she would like to help out the Town again if the need arises.

**Easement:**

Chairman Larson updated the Board regarding the easement he was looking into off Barre Road on Turkey Roost Road. Chairman Larson was contacting DCR to look into whose land the ATV's were riding on when we received the noise complaints. DCR needed to look into it further and gave Chairman Larson a contact at DCR who would go out and survey it. When Chairman Larson hears from Mr. Steve Wood, he will update the Board further.

**Permits:**

A permit was signed for Ratta Corporation to install septic.

**Resignation:**

Hayden Duggan had written a letter to let the Board know that although he finds it very difficult, he feels that due to his work schedule, he needs to resign. After the Board discussed this, they determined that Randy Mizereck will call Hayden Duggan to discuss this situation.
