

**Hubbardston Conservation Commission Minutes**

**Library Basement**

Meeting called to order at 7:01 p.m. in the Hubbardston Library Conference Room located in the Library Basement.

**First Order of Business:**

Jason Chagas came to the meeting to discuss work he would like to do to his driveway which would help with the drainage.
